

Places are limited and we will attempt to prioritise from the responses on the submitted forms.


The DEADLINE for applications is 8am on the 9th December 2024.

- > The course is designed for around 30 participants each year.
- The course runs for about 60 hours across 7 months
- > Participants have full access to an allocated Tutor with 1-2-1 time written into the Programme

There's plenty of additional online and video content and bespoke sessions as needed by participants. The course is designed around participant needs and is updated every year to reflect feedback. All sessions are online and timed as best we can around school holidays and parenting duties.
